

REACH/SVHC Statement

The European Union Regulation (EC) No. 1907/2006 Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) aims to protect human health and the environment by reducing and restricting the use of most hazardous chemical substances. Companies supplying articles containing in a concentration above 0.1% by weight a Substance of Very High Concern (SVHC) identified on the REACH Candidate List (REACH Article 59(1)) on the EU market, must communicate the presence of a SVHC in the article further in the supply chain (REACH Article 33). It does not impose any restrictions on the use of the product(s), nor is it a substance ban.

To the present and best of our knowledge and based upon the information available to us from our suppliers, QuikRead go Plus Instrument and its accessories contain SVHC substances as indicated in the following table.

Information on safe use: The SVHCs are bound inside the Product(s) and not released during a regular use. Specific precautions in handling are not required. The Product(s) should be disposed/recycled in accordance with all applicable governmental regulations relevant to the geographical location.
